

## Rehoboth Beach Main Street, Inc. (RBMS) SIGN & AWNING MATCHING GRANT APPLICATION

Rehoboth Beach Main Street, Inc. (RBMS) will reimburse up to \$500.000 of the cost for a sign or an awning for commercial properties located within the RBMS designated district boundaries (the City of Rehoboth Beach proper), for a total project cost of \$1,000.00 minimum per building.

The maximum matching grant is not to exceed \$500.00 for a sign or awning.

A matching grant will be awarded to projects whose business and/or property owners have obtained a City of Rehoboth Beach permit from the Building Inspector and have made payment of the permit fee prior to the start of work.

A confirmation of approved permit and proof of payment of permit fee must be provided prior to installation or construction.

Matching grant funds are released as a reimbursement after approved work is completed, invoices are paid, required documentation is submitted and a site visit is conducted by a RBMS Design Committee member.

Matching grants are awarded on a "first come, first served" basis.

- 8" x 10" color photograph of existing façade (a copy from laser printer is acceptable)
- Proposed sign or awning plan drawn to ¼ inch scale
- Estimated cost breakdowns (include costs for labor and materials)
- Materials specifications (include samples of paint colors for all parts of signs, awning fabric samples, samples of any replacement materials being considered for replacement in kind)
- 8" x 10" color photograph showing the buildings adjacent to each side of the property (copies from laser printer are acceptable)
- Copies of approved permit and proof of payment of permit fee
